AMENDED *JAB*
AN ORDINANCE PROHIBITING MEDICAL MARIJUANA CULTIVATORS, PROCESSORS AND ~~RETAIL DISPENSARY~~ 6-19-17
~~DISPENSARY~~ ESTABLISHMENTS LICENSED UNDER OHIO REVISED CODE CHAPTER 3796 WITHIN
MUNICIPAL LIMITS OF THE CITY OF HUBBARD, AND DECLARING AN EMERGENCY.

WHEREAS, the Ohio legislature has adopted Chapter 3796 entitled Medical Marijuana Control Program; and

WHEREAS, Ohio Revised Code Section 3796.29 provides that the legislative authority of a municipal corporation may adopt an ordinance to prohibit, or limit the number of, cultivators, processors or retail dispensaries licensed under Chapter 3796 within the municipal corporation; and

WHEREAS, the City of Hubbard desires to prohibit the cultivation, processing, ~~and retail dispensing~~ *JAB*
of medical marijuana within the municipal limits.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

JAB
SECTION 1: The cultivation, processing or ~~retail dispensing~~ of medical marijuana, even under a license issued under Chapter 3796 of the Ohio Revised Code, is prohibited within the City of Hubbard. The violation of this Ordinance is a misdemeanor of the fourth degree.

SECTION 2: This Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard Ohio and for the preservation of the business district.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
