AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO AN AGREEMENT WITH R.T. VERNAL PAVING AND EXCAVATING FOR THE 2018 STREET RESURFACING PROGRAM, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio, deems it necessary to repair and/or resurface certain city streets, as contained in the 2018 Street Resurfacing Program currently on file with the City of Hubbard City Engineer's Office; and

WHEREAS, streets to be resurfaced were advertised or bid pursuant to law, and

WHEREAS, further delays with the resurfacing program will most likely cause irreparable damage to the streets and substantially increase the cost of repairing said streets.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio, be and hereby is authorized to enter into an agreement and contract with R.T. Vernal Paving and Excavating accepting the bid in the amount of \$197,089.75 for the completion of the 2018 Street Resurfacing Program, in accordance with identified streets as described in the bid specifications as prepared by CT Consultants and the City Engineer's Office.

SECTION 2: The City Auditor is hereby authorized and directed to encumber all necessary funds in the appropriate funds, #205 Street Construction and Maintenance; and #405 Capital Improvement.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the fact that there exists a need to preserve the public property of the City of Hubbard, Ohio, and further delays in resurfacing and/or repairing the affected streets will cause irreparable damage to said streets and substantially increase the cost of repairing said streets, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
