ORDINANCE NO. 15-17

AN ORDINANCE

CREATING THE POSITION OF WATER ADMINISTRATOR FOR THE CITY OF HUBBARD, AND
DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio operates and maintains a municipal water
system; and

WHEREAS, the City of Hubbard municipal water system must be in compliance
with EPA rules and regulations; and

WHEREAS, the City Council of the City of Hubbard, Ohio wishes to establish the
position of a Water Administrator to meet the EPA requirements and maintain
water quality.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County,
Ohio:

SECTION 1: The position of Water Administrator is hereby created.

SECTION 2: The position of Water Administrator shall be compensated at a rate
of \$1,000.00 per month, with participation in Ohio Public Employee Retirement
Services.

SECTION 3: The duties of the Water Administrator is to supervise and direct
operations of the City of Hubbard Water Department employees, assist Service Director
in planning for improvements for city water service, and advise on EPA programs.
Administrator will be responsible for the City's compliance with EPA reporting and
requirements. The Water Administrator must meet or exceed the EPA license
requirements for the City of Hubbard. The Water Administrator will be appointed by
and report to the Service Director.

SECTION 4: This Ordinance is hereby declared to be an emergency measure and
shall take effect immediately upon passage and approval by the Mayor for the reason
that it is necessary for the health, safety, and welfare of the citizens of the City of
Hubbard Ohio, to maintain water quality for all citizens, and to comply with EPA
requirements.

SECTION 5: All prior Ordinances or parts thereof in conflict with this Ordinance
are hereby repealed.

SECTION 6: All formal actions of the City Council of Hubbard, Ohio relating to the
adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio
and any of its committees leading to such action, were in meetings open to the public as
required by law.
