AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH J. S. BOVA EXCAVATING, LLC, FOR THE SR304 WATERLINE REPLACEMENT PROJECT FOR A COST NOT TO EXCEED \$218,060.00, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio deems it necessary to replace the SR304 Waterline's multiple breaks and to enhance the quality of drinking water; and

WHEREAS, the SR304 Waterline Replacement Project was advertised and bid pursuant to law; and

WHEREAS, J. S. Bova Excavating, LLC has submitted the lowest qualified bid for the project.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio, is hereby authorized to enter into a contract with J. S. Bova Excavating, LLC accepting the Base Bid plus Alternates "A" and "B" in the amount of \$218,060.00 for the completion of the SR304 Waterline Replacement Project in accordance with plans and specifications as prepared by ms consultants, inc.

SECTION 2: The City Auditor is hereby authorized and directed to encumber all necessary funds in the appropriate Water Replacement & Improvement Fund, Line Item No. 725-5020-52340.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
