AN ORDINANCE

AUTHORIZING THE SAFETY DIRECTOR TO EXECUTE A MEMORANDUM OF UNDERSTANDING BETWEEN THE CITY OF HUBBARD AND THE HUBBARD EXEMPTED SCHOOL DISTRICT FOR THE GUIDELINE AND POLICIES GOVERNING THE PERFORMANCE OF A SCHOOL RESOURCE OFFICER AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio wants to prevent and reduce potential harm related to incidents of school violence and foster a positive school climate; and

WHEREAS, the Hubbard Exempted School District wants to ensure a safe learning environment for all children and adults who enter the public schools; and

WHEREAS, together create a partnership to fulfill the goals of law enforcement, crime prevention, positive school climate, and education.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Safety Director is hereby directed to execute a Memorandum of Understanding between the City of Hubbard and the Hubbard Exempted School District for the guideline and policies governing the performance of a School Resource Officer.

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
