AN ORDINANCE

AN ORDINANCE APPROVING THE SOLID WASTE MANAGEMENT PLAN OF THE GEAGA TRUMBULL SOLID WASTE MANAGEMENT DISTRICT

WHEREAS, the Geauga Trumbull Solid Waste Management District, by its Solid Waste Management Policy Committee, has adopted a Solid Waste Management Plan for the District; and

WHEREAS, pursuant to Ohio Revised Code Section 3734.55(B), the Board of County Commissioners and the legislative authority of each municipal corporation or township under the jurisdiction of the District, must approve or disapprove the Plan by ordinance or resolution; and

WHEREAS, the City of Hubbard, Trumbull County, Ohio have reviewed the Plan and considered it at a duly called meeting; and

WHEREAS, the Plan furthers the public interest.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the Solid Waste Management Plan of the Geauga Trumbull Solid Management District, adopted by the Solid Waste Management Policy Committee on January 14, 2019, is hereby approved.

SECTION 2: That a copy of this Ordinance of Approval shall promptly be delivered, or caused to be delivered, to the Solid Waste Management Policy Committee of the Geauga Trumbull Solid Waste Management District.

SECTION 3: This Ordinance is hereby declared to be an emergency, necessary for the immediate preservation of the public health, safety, and welfare for the reason that solid waste management is a primary concern and the activities of the Geauga Trumbull Solid Waste Management District need to proceed without delay.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
