ORDINANCE NO. 28-18

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH CT CONSULTANTS FOR PROFESSIONAL ENGINEERING SERVICES FOR THE WATER POLLUTION CONTROL FACILITY (WPCF), PHASE 2 IMPROVEMENTS, FOR THE AMOUNT NOT TO EXCEED \$130,000.00, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio needs to operate its WPCF in an efficient and lawful manner, and

WHEREAS, the WPCF requires upgrading to remain in compliance with current and future regulations.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: CT Consultants, Inc. has delivered the lowest and most qualified proposal to the City of Hubbard.

SECTION 2: That the Board of Control is authorized and directed to execute and award a contract with CT Consultants, Inc. not to exceed \$130,000.00.

SECTION 3: Funding shall be from WPCF Contract Wages, Fund No. 730-5030, Line Item No. 52340.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 6: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
