AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONSTRUCTION CONTRACT WITH A. P. O'HORO COMPANY, YOUNGSTOWN, OHIO FOR THE PHASE 2 UPGRADE PROJECT FOR THE CITY'S WASTE WATER TREATMENT PLANT AT THE COST OF \$1,268,000.00, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio deems it necessary to update the municipal waste water treatment plant; and

WHEREAS, the Phase 2 Upgrade Project was advertised and bid pursuant to law; and

WHEREAS, A. P. O'Horo Company has submitted the lowest qualified bid for the project.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio, is hereby authorized to enter into a contract with A.P. O'Horo Company accepting the Base Bid in the amount of \$1,268,000.00 for the completion of the Phase 2 Upgrade Project for the Waste Water Treatment Plant in accordance with the bid specifications as prepared by CT Consultants.

SECTION 2: The City Auditor is hereby authorized and directed to encumber all necessary funds in the appropriate construction fund.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
