A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO AN AGREEMENT WITH TRUMBULL COUNTY, OHIO FOR INDIGENT DEFENSE SERVICES FOR THE PERIOD OF JANUARY 1, 2018 THROUGH DECEMBER 31, 2018.

WHEREAS, the City of Hubbard, Ohio, recognizes its' responsibility under the laws of the State of Ohio and the United States of America to provide legal counsel to indigent persons charged with a violation of City Ordinances for which the penalty or any possible adjudication includes the potential loss of liberty; and,

WHEREAS, Trumbull County, Ohio has adopted a program whereby the County Commissioners have contracted with the State of Ohio to provide indigent defense services in Trumbull County; and

WHEREAS, an Agreement has been prepared and proposed for said indigent services whereby the City of Hubbard will pay Trumbull County \$500.00 for said indigent defense services for the period January 1, 2018 through December 31, 2018.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio is hereby authorized to enter into an Agreement with Trumbull County, Ohio for indigent defense services as described above. (A copy of said Agreement is attached hereto as Exhibit A and incorporated herein as if full re-written).

SECTION 2: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
