A RESOLUTION

**A RESOLUTION THAT THE RESIDENTS, ELECTED OFFICIALS AND EMPLOYEES OF THE CITY OF HUBBARD, OHIO OFFER THEIR FULL AND UNCONDITIONAL SUPPORT TO THE UNION AND MANAGEMENT EMPLOYEES OF GM LORDSTOWN FACILITY AND OTHER COMPANIES THAT MAY BE AFFECTED BY RECENT ANNOUNCEMENTS.**

WHEREAS, recent announcements by General Motors have cast an uncertain future on the GM Lordstown facility.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The residents, the elected officials, and the employees of the City of Hubbard offer their full and unconditional support to the union and management employees of the General Motors Lordstown Facility and any other company that may be affected by recent announcements.

SECTION 2: We implore our elected officials including President Donald Trump, Senator Brown, Senator Portman, Congressman Ryan, Congressman Johnson, our state senators, our state representatives, Governor Kasich, and Governor-Elect DeWine to put all partisan differences aside and resolve that the idling of the Lordstown Facility is not an outcome that will be accepted. This plant can and must be saved. The City of Hubbard offers its full support to these efforts.

SECTION 3: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
