A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO AN AGREEMENT FOR THE ESTABLISHMENT AND MEMBERSHIP OF THE TRUMBULL COUNTY COUNCIL OF GOVERNMENTS.

WHEREAS, the Ohio Revised Code ("ORC") Chapter 167 authorizes certain political subdivisions to enter into agreements establishing a regional council of governments (COG) for the purpose of providing certain public services on a cooperative basis, and

WHEREAS, the City of Hubbard, Ohio now desires to enter into, and to authorize the execution of the COG Agreement for the Year 2018, and

WHEREAS, there will be dues collected established for the year of 2018, based upon the population of the City of Hubbard.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: This Resolution shall take effect and be in full force upon passage in accordance with all applicable provisions and sections of the charter.

SECTION 2: All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
