AN ORDINANCE

AMENDING SECTION 2 OF THE CITY OF HUBBARD ORDINANCE NO. 25-18 CLARIFYING COMPENSATION/BENEFITS OF THE WASTEWATER SUPERINTENDENT OF THE CITY OF HUBBARD.

WHEREAS, the City Council of the City of Hubbard wishes to provide equal benefits between salaried superintendent positions; and

WHEREAS, to clarify and eliminate ambiguities regarding compensation/benefits among salaried supervisory positions.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That Section 2 of the City of Hubbard Ordinance No. 25-18 is hereby amended and shall read as follows:

The Wastewater Superintendent, shall be entitled to and granted participation in the Ohio Public Employees Retirement System and shall receive hospitalization, medical benefits, and prescription drug coverage, and other benefits granted to the City of Hubbard employees by way of collective bargaining agreements, and such other benefits as from time to time may be awarded unless otherwise excluded by valid resolution or ordinance of this Council. . The Wastewater Superintendent shall be entitled to compensatory time at a maximum rate of 1.5 times the regular rate of pay. All compensatory time must be used by year end or otherwise forfeited and shall have no cash buyout value. All compensatory time must be approved by the Service Director and subsequently reported to the Auditor's Office for record keeping purposes. The Wastewater Superintendent shall accrue sick leave as provided by Ohio Revised Code for Ohio public employees. The Wastewater Superintendent shall be entitled to two (2) weeks paid vacation after completion of twelve (12) months of service, and two (2) weeks vacation for each service year thereafter. Vacation time may accrue to a maximum of four (4) weeks total, after which it shall be forfeited. This position is excluded from participation in the Early Retirement Incentive program afforded to the AFSCME bargaining unit members.

SECTION 2: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law
