A RESOLUTION

AUTHORIZING THE CITY OF HUBBARD TO ENTER INTO AN AGREEMENT WITH THE GEAGA-TRUMBULL WASTE MANAGEMENT DISTRICT FOR PROPERTY FOR A FIXED RECYCLING DROP-OFF PROGRAM FOR THE PERIOD OF JANUARY 1, 2020 THROUGH DECEMBER 31, 2022.

WHEREAS, funds for the program have been authorized by the Geauga-Trumbull Waste Management District from January 1, 2020 through December 31, 2022; and

WHEREAS, the City of Hubbard will make available to the Geauga-Trumbull Waste Management District property for a fixed recycling drop-off program; and

WHEREAS, the City of Hubbard authorizes and enters into an agreement for their participation in the drop-off program and to set forth the dates and times it will be available; and

WHEREAS, the Geauga-Trumbull Waste Management District will contract with an approved waste hauler for the removal of recyclables from the containers; and

WHEREAS, funds for the program will be issued only to the approved waste hauler for the removal of recyclables for the program.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Geauga-Trumbull Waste Management District hereby leases from the City of Hubbard and the City of Hubbard hereby leases to the Geauga-Trumbull Waste Management District, space to be used for the housing of 8-cubic yard front load recycling containers, for a total of 36 months, commencing January 1, 2020 and terminating December 31, 2022, unless extended by written agreement before that date or otherwise terminated as provided herein.

SECTION 2: The Geauga-Trumbull Waste Management District will promote the drop-off program.

SECTION 3: The City of Hubbard will notify the Geauga-Trumbull Waste Management District in writing of any problems or complaints that are directly related to the drop-off program.

SECTION 4: The Geauga-Trumbull Waste Management District will include in its written agreement with the waste hauler provisions that indemnify and hold harmless the Geauga-Trumbull Waste Management District and the City of Hubbard for acts of negligence related to the waste hauler's participation in the program.

SECTION 5: The City of Hubbard agrees to indemnify and hold harmless the Geauga-Trumbull Waste Management District from any liability for acts of negligence related to the City of Hubbard's participation in the program.

SECTION 6: The Geauga-Trumbull Waste Management District shall outline what recyclables are to be collected and the overall requirement of the program, and the City of Hubbard shall abide by the guidelines of the proposed recycling drop-off activity.

SECTION 7: The Geauga-Trumbull Waste Management District is not responsible for any materials, recyclable or non-recyclable, left at the drop-off site when the containers are full or otherwise not available to the public.

SECTION 8: The City of Hubbard will make the site available to the public for the drop-offs daily during daylight hours as well as to the waste hauler for pickups between 6:00 a.m. and 9:00 p.m.

SECTION 9: No funds will go to the City of Hubbard for its participation in the recycling drop-off program.

SECTION 10: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 11: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
