A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ADVERTISE FOR QUALIFICATIONS FROM PROFESSIONAL ENGINEERING FIRMS TO PROVIDE GENERAL ENGINEERING, ARCHITECTURAL AND PLANNING SERVICES.

WHEREAS, the Service Director, on and behalf of the City of Hubbard Board of Control, has the statutory authority to advertise for professional qualifications for general engineering, architectural, and planning services; and,

WHEREAS, the City Council of Hubbard, Ohio, deems it necessary to authorize the Service Director and Board of Control to perform the duties placed upon them by the Ohio Revised Code; and,

WHEREAS, the City Council of Hubbard, Ohio realizes a need to solicit qualifications from professional engineering firms.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control and Service Director are hereby authorized and directed to advertise for Requests for Qualifications from engineering firms to provide general engineering, architectural and planning services for the City of Hubbard.

SECTION 2: A copy of the advertisement is attached as Exhibit A.

SECTION 3: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
