SAFETY DIRECTOR- Lou Carsone – Thank you Mr. President, again as reported in caucus, it is my intention as long as everything is good with the School Board to sign the Memorandum of Understanding for a School Resource Officer that would start as soon as we could get an officer trained. The training class is scheduled for October. Again, thank you to everybody who helped support and helped with this. The Mayor for his support and looking at the framework, for the input for the memorandum from the Auditor, the work done by the Law Director with the School's Legal Counsel and for council for your support on this. I would like to thank the Police Chief for the work he put into this too. I know he spent a lot of time reading and rereading, writing and rewriting of that agreement. Thanks to all, this should be wrapped up tomorrow. As soon as we do that, we will make a conditional offer of employment to hire a police officer to help us fill that. Our disaster drill is on the 27^{th,} beginning at 9:00 in the morning. We are going to run from 9 to 12. Anyone who wants to participate, observe or be in the command post please let me know. I want to bring up one other thing, last week you had the monthly report on the police cruisers. I apologize, I did not bring that form with me, so I don't know exactly which car it was. One of the newer SUV's had a repair cost of about \$3,500.00. I would like to point out that was for the mobile data terminal. That was the computer in the car that we needed to replace. It was not a mechanical issue with one of our new SUV's. That is what that cost was for. That is all I have Mr. President

SERVICE DIRECTOR-Dan Livingston- Yes Mr. President, just three quick things. I spoke with Gene Butch today from Butch & McCree. Our pre-con for the Drummond Avenue Project is this Thursday at 10 am. I wanted to get some starting dates to report tonight. As of right now, they are looking to do it on the 15th of October. That would be the latest start. They might do it on the 3rd. They have some situations going on in Poland that they might not be able to start with because of ODOT. They might move us up and move them back. Definitely, Drummond Avenue will be started no later than October 15th. We had that meeting with CT about the Waste Water Treatment Plant. We are going out for bids. You gave us authorization to go out for bids. We are going to advertise this Thursday, September 20th and 27th. There is going to be a pre-bid conference on October 3rd. The bid opening will be October 10th for the Waste Water Treatment Plant. That is the schedule there. I have advertised in the paper now twice. This week will be the second week for leaf rakers.
