AN ORDINANCE

**ADJUSTING THE COMPENSATION OF THE SAFETY DIRECTOR OF THE CITY OF HUBBARD TO THE RATE OF \$1400.00 PER MONTH.**

WHEREAS, the City Council of the City of Hubbard, Ohio wishes to compensate the Safety Director of the City of Hubbard, Ohio at a rate of pay commensurate with the duties and responsibilities of the position and office.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The salary of the Safety Director of the City of Hubbard, Ohio shall be commencing with the effective date of this Ordinance in the amount of \$1400.00 per month.

SECTION 2: The Safety Director shall be entitled to and granted participation in the Public Employees Retirement System, and life insurance unless excluded by valid resolution or ordinance of this City Council.

SECTION 3: The City Auditor is hereby authorized and directed to appropriate the necessary funds from the proper City line items and funds in accordance with the relevant percentages to effectuate the foregoing provisions.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
