AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT FOR THE DEMOLITION OF 120 JACKSON STREET, HUBBARD, OHIO PER CHAPTER 1345 OF THE CODIFIED ORDINANCES OF THE CITY OF HUBBARD, OHIO.

WHEREAS, the City of Hubbard Building Code provides for the abatement of deteriorated structures ; and

WHEREAS, the property owners, per Chapter 1345 of the City of Hubbard Building Code, were mailed notice of the deficiencies of the property; and

WHEREAS, the building has been deemed abandoned, not fit for habitation, and structurally defective; and

WHEREAS, the property owners have failed to make repairs within the allotted time.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County Ohio:

SECTION 1: That the Board of Control is authorized and directed to complete the demolition of the structures at 120 Jackson Street, Hubbard, Ohio according to the provisions of Chapter 1345 of the City of Hubbard Codified Ordinances.

SECTION 2: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
