A RESOLUTION

**AUTHORIZING THE AUDITOR TO ADVERTISE FOR BIDS FOR A COMPLETE PACKAGE OF VARIOUS INSURANCES FOR THE CITY OF HUBBARD, OHIO FOR THE 2019-2021 POLICY YEARS.**
