A RESOLUTION

AUTHORIZING THE SERVICE DIRECTOR TO PREPARE AND SUBMIT AN APPLICATION TO PARTICIPATE IN THE OHIO PUBLIC WORKS COMMISSION STATE CAPITAL IMPROVEMENT AND/OR LOCAL TRANSPORTATION IMPROVEMENT PROGRAM(S) AND TO EXECUTE CONTRACTS AS REQUIRED, AND DECLARING AN EMERGENCY.

WHEREAS, the State Capital Improvement Program and the Local Transportation Improvement Program both provide financial assistance to political subdivisions for capital improvements to public infrastructure, and

WHEREAS, the City of Hubbard hereby requests a grant in the amount of \$224,512.00 from the Ohio Public Works Commission as local share for the Ohio Department of Transportation SR 304 Resurfacing Project; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Service Director is hereby authorized to apply to the OPWC for funds as described above.

SECTION 2: The Service Director is authorized to enter into any agreements as may be necessary and appropriate for obtaining this financial assistance.

SECTION 3: The Auditor is hereby designated as Chief Fiscal Officer relative to all grant documents pertaining to the SR 304 Resurfacing Project.

SECTION 4: That this Resolution is hereby declared to be an emergency necessary for the preservation of the public peace, health, safety, and welfare of the citizens of the City of Hubbard. Said emergency exists by reason that it is necessary to submit a passed copy of this Resolution with the final Ohio Public Works Commission Funding Application that is due at the Eastgate Regional Council of Governments on December 21, 2018 in order to secure appropriate funding for the SR 304 Resurfacing Project.

SECTION 5: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 6: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
