A RESOLUTION

AUTHORIZING AN AGREEMENT BETWEEN THE CITY OF HUBBARD AND THE FRATERNAL ORDER OF POLICE TO WAIVE THE PROVISIONS OF 4117.14(G)(11).

WHEREAS, the City of Hubbard, Ohio and the Fraternal Order of Police, Ohio Labor Council, Inc. wish to employ a conciliator during the compensation negotiation process; and

WHEREAS, the conciliator is necessary to accommodate the negotiation process.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The City of Hubbard and the Fraternal Order of Police, Ohio Labor Council, Inc. hereby agree to waive the provisions of 4117.14(G)(11) to the extent necessary to allow a conciliator to issue an award with an effective date that is on or after January 1, 2018 for rates of compensation and/or any other matters with cost implications. By agreeing to this waiver, the parties do not indicate a preference that all economic matters be effective on a particular date; rather the parties' intent is to accommodate the negotiation process.

SECTION 2: The parties further agree to extend the date for the issuance of any Fact-finding Report to May 31, 2018.

SECTION 3: All prior Resolutions and Ordinances, or parts thereof, in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
