A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ADVERTISE FOR BIDS FOR THE PURCHASE OF GASOLINE FOR CITY VEHICLES FOR THE 2018-2020 CALENDAR YEARS.

WHEREAS, the City of Hubbard, Ohio, uses gasoline in the operation of various city equipment and vehicles; and,

WHEREAS, the amount of fuel purchases is likely to exceed an amount whereby the City of Hubbard, Ohio, would be required to advertise for bids for the purchase of said fuel.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to advertise for bids for the purchase of gasoline for city vehicles for the 2018-2020 calendar years.

SECTION 2: This Resolution is hereby declared to be an emergency measure, necessary for the health, safety, and welfare of the City of Hubbard, Ohio, by virtue of the fact that the City of Hubbard, Ohio is obligated to use this product for operation and safety of municipal operations and the current contract is about to expire, and as such, this Resolution shall take effect immediately upon its passage and approval by the Mayor, or, in the alternative from and after the earliest time permitted by law.

SECTION 3: All prior Ordinances and Resolutions or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
