It was moved by Mr. O'Hara with a second by Ms. Viele to accept the minutes from the April 15, 2019 regular session as presented to council. There were no questions or comments on the motion. Motion passed. Vote unanimous.

SAFETY- Mr. O'Hara- Yes, thank you Mr. President, Safety Director Carsone had notified me earlier in the week and had provided me some information. Recently, a conduit which houses several data transmission lines between the Municipal Building and the Police Department was leaking water into the basement of the Police Department. The problem was found to be a break in the conduit. Superintendent Mr. Palestro repaired the break in the conduit solving the problem. While investigating the leak into the Police Department basement, it was discovered that the water retention system for the Police Department was collapsing. MS Consultants is currently reviewing the system and will be providing suggestions and costs in repairing the sinking retention pond. That is all.

REPORTS OF CITY OFFICIALS

SAFETY DIRECTOR- Lou Carsone- Thank you Mr. President, a couple of items. First of all, a follow up on Councilman O'Hara's report. Late this afternoon, Mr. Palestro advised me that MS Consultants will be providing us with two options to repair or replace that retention system late this week or early next week. I will let everyone aware when I get those. I have no idea what the cost is going to be or what the solutions will be. I will keep everybody updated on that. In another matter, we have had some issues with parking on the street at the corner of North Main and Walnut due to the ice cream place that just moved in there. People are parking right up to the intersection making it difficult to turn onto Walnut Street and difficult to see turning out of Walnut. There were never any no Parking signs from here to corner to keep traffic away from those corners. I spoke to Mr. Palestro last week and we went down and staked that out. There will be no parking here to corner signs put up shortly that should alleviate that parking problem on the street. In another matter, since we lost one of our clerks, who took the position as the Mayors Secretary, we have begun our search for a new clerk at the police department. We have received some applications and resumes, and we will begin the process to find a new clerk. Also, Sgt. Thompson, you all know will be the new police Chief on the retirement of Jim Taafe at the end of the year, has begun shadowing Chief Taafe and is beginning to delve into the ins and outs of that particular job. That is all I have.

It was moved by Ms. Viele with a second by Mr. O'Hara to have the Law Director draw up the necessary legislation authorizing MS Consultants on behalf of the City of Hubbard to file the Nature Works application with the Ohio Department of Natural Resources.

Mr. Williams- thank you Dan. I didn't even look to see that.

Ordinance 5-19 First Reading

ADOPTING AN ALTERNATIVE TAX BUDGET FOR THE CITY OF HUBBARD, OHIO FOR THE FISCAL YEAR COMMENCING JANUARY 1, 2020 AND SUBMITTING COPIES OF SAME TO THE TRUMBULL COUNTY BUDGET COMMISSION.

Mr. Williams- Since there is no action on Ordinance 5-19 it will flow to a second reading

Mr. Williams- is there anyone who would like to address council on non-agenda items related to city council business when recognized please step forward to the microphone and state your name and address for the record. You will have three minutes unless extended by council vote.

Tim Brannan 634 Moore Street. Majority of you people know me. You don't see me that often up here. Maple Grove cemetery is terrible. You got a good guy down there cutting. Dutch is a hard worker. I have nothing bad to say about him, but you guys waited too long to get him down there. That grass is 2 feet high. I mean it is up to my knees. It is a disgrace. You guys are supposed to be taking care of that. You people but yet you don't. Your Planning & Zoning Director goes around this town and notifies your elder, disabled and poor people about their lawns being too high and to do something about it. Yet you guys don't see it. You guys don't see the cemetery so, out of sight out of mind. It is ridiculous. You have Dave Cook who stopped down today to check on Dutch to make sure he got everything smooth. I have nothing bad to say about Dave Cook either. He is a hard worker. Every time I see him, he is doing something. Whenever I see Dave Cook cutting grass, at the McBride House or down at Tylee Park, with his knowledge. I wouldn't think that somebody that was hired in at the street department or friends and family let them cut the grass. Dave has got too much knowledge.

Mr. Williams- What did you just say?

Mr. Brannan- I said, whenever people gets hired into the city offices, into the city wherever, whether it is friends or family, let them go down and mow the grass.

Mr. Williams- That is the street departments responsibility to mow the grass there.

Mr. Brannan- Oh, there is enough of them. It doesn't have to be Dave Cook.

Mr. Williams- That is not our call.

Mr. Brannan- A lot of those guys aren't even knowledgeable, and you have outsourcing getting ditches clean. The street Department use to do the streets, sweep the streets and don't do that anymore. That is being outsourced. The sewage drains were done by the street department. That was outsourced on Park. Then you had a city worker standing there scratching his head leaning against a truck watching them.

Mr. Williams- Is that true Dan? City worker was standing there watching.

Mr. Livingston- What?

Mr. Williams- A city worker was standing there watching an outside contractor...where at?

Mr. Brannan- on Park. They were putting a line down the sewer and snaking it.

Mr. Livingston- They were cameraing it.

Mr. Brannan-what ever

Mr. Livingston-Well we don't have a camera. We were cameraing lines to see which ones need fixed and which ones are cracked and separated. That is what you seen shoving down there. The city does not have or can afford that kind of equipment. That is all that company does is camera lines and clean them out. They don't repair them.

Mr. Brannan- This ain't the first time I have been up here talking about Maple Grove Cemetery. You know a portion of the taxes from the township and the city pays to have a crew up at union. Is that correct?

Mr. Williams-yes

Mr. Brannan- Since you don't have the money to go down and do Maple grove and you only have one person there, why don't you send that crew up there that keep that cemetery looking like a golf course?

Mr. Williams- They aren't city employees. They don't work for the city.

Mr. Brannan- Who pays them?

Mr. Williams- Hubbard Union Cemetery does. It is a separate entity.

Mr. Brannan- It's a separate entity. So, the city doesn't do that?

Mr. Williams- The city tax dollars go to it but the city itself...no it doesn't. The city and the township oversee it.

Mr. Brannan- Peoples taxes go to them, but they don't got anything to do with the city? Is that what you are telling me?

Mr. Williams- Yes, we do not maintain Hubbard Union Cemetery.

Mr. Brannan- I understand you don't maintain it.

Mr. Williams- A board oversees it.

Mr. Brannan- It is the taxpayer's money from the city and township.

Mr. Williams-It is a separate entity from the city. Why aren't you at the township trustees' meetings telling them to go send their people to go do it.

Mr. Brannan- Because they are right here.

Mr. Williams- Why didn't you tell them? Did you go to their meeting and tell them the same thing?

Mr. Brannan- I could do that?

Mr. Williams- Those people don't work for the city. They don't work for us. They are not our employees. They are employed by the Hubbard Union Cemetery.

Mr. Brannan-Okay

Mr. Williams- and your comments about the street sweeping, how much did we save by not using our old street sweeper that was falling apart?

Mr. Livingston- \$ 30,000 a year

Mr. Williams- That is why we did that!

Mr. Brannan- That way the guys can take and ride around in your trucks some more.

Mr. Williams- Do you really think that Tim?

Mr. Brannan- Yea I do. I am not

Mr. Williams- That we would make a decision like that

Mr. Brannan- I am not the only one that sees the city trucks lingering out in the township.

Mr. Williams- Where in the township?

Mr. Brannan- I can't recall

Mr. Williams- Oh okay. Is his three minutes up yet?

Clerk-yes

Mr. Williams- Would anyone like to extend his three minutes?

Mr. Brannan- It took me a while.

Mr. Toda- I will extend his three minutes.

Mr. Williams- Is there a second?

Mr. Crowe- second

It was moved by Mr. toda with a second by Mr. Crowe to extend the time by

Mr. Toda- 5 minutes

Mr. Livingston- You can't do it. It has to be by 3 increments

Mr. Toda- Oh, by 3-minutes okay. 6 minutes

Mr. Williams- What?

Mr. Livingston- No, it is three minutes each time.

Mr. Toda- Well, three minutes then.

Mr. Williams- Okay by three minutes.

It was moved by Mr. Toda with a second by Mr. Crowe to extend the time by three minutes. There were no questions or comments on the motion. Motion passed. Vote unanimous.

Mr. Williams- Okay, you can continue now. What else would you like to talk about?

Mr. Brannan- Well, I would like to find out what you are going to do about the cemetery?

Mr. Williams- Have you spoken to Mr. Livingston?

Mr. Brannan- No, I haven't.

Mr. Livingston- Is he down there cutting today?

Mr. Brannan- Yes, he was.

Mr. Livingston- Was there two young gentleman weed whacking today?

Mr. Brannan- There was.

Mr. Livingston- We will catch up. It has been a little wet number one. I stop down there today. I seen you down there around your family plot I believe.

Mr. Brannan- That is correct. It was me and my wife and it is two hours. It took us four hours to clear our lots.

Mr. Livingston- Mr. Schuller was on the tractor with the two younger boys were cutting the weeds.

Mr. Brannan- That is true.

Mr. Livingston- They will be cutting their everyday this week.

Mr. Brannan- I don't want to hear it is too wet to get back there.

Mr. Livingston- Well, it is not going to dry out until we cut it.

Mr. Brannan- That is correct, the thing about it is as well as that thing is tapered there aint no standing water. So, it can be cut.

Mr. Livingston- I never said there was any standing water.

Mr. Brannan- You guys just goofed. You waited too long. If you can go around and tell elderly to get their grass cut, then you guys can get down there and cut that. Planning & Zoning is going around and telling people that they need to get their grass mowed.

Mr. Livingston- Yea, if they don't cut it

Mr. Brannan- Well what is good for them, is good for you.

Mr. Livingston- That is what we are doing down there. We are cutting it.

Mr. Brannan- Well, you don't wait until it gets 2 feet high!

Mr. Livingston- I didn't see anything 2 ft high down there.

Mr. Brannan- Oh, you are full of crap. I got

Mr. Williams- Whoa! Whoa! We don't talk like that here.

Mr. Brannan- What is crap a

Mr. Williams- That is the last time you are going to say that.

Mr. Brannan- Is that a bad word?

Mr. Williams- Yea we don't talk...please sit down. That is it. That is it, please sit down. I am not going to have

Mr. Brannan- I don't understand

Mr. Williams- Please sit down. Is there anyone else who wishes to address city council?

I want to make a comment. I am on the Cemetery Board

Mr. Williams- If you could

Tom Jacobs-The other two Mr. Silvidi and Ms. Baumiller. You said the grass is two feet high?

Mr. Williams- at Maple Grove

Mr. Livingston- at Maple Grove

Mr. Williams- but not at Hubbard Union. What he stated about Hubbard Union is we should have the employees of Hubbard Union cut Maple Grove Cemetery. I explained to him we can't.

Mr. Jacobs- We have our hands full with Hubbard Union. We don't have time to go to Maple Grove to do that.

Mr. Williams- We couldn't do that legally anyhow.

Mr. Jacobs- no that is right. The people that are working Hubbard Union are strictly doing work for Hubbard Union. We cannot have our workers going to another cemetery doing work.

Mr. Brannan-I understand what you are saying but maybe they ought to get crew every year to go down there.

Mr. Jacobs- Who is going to pay for it?

Mr. Williams- Look guys we are not going to have a discussion out on the floor. Thank you, is there anyone else who wishes to address city council this evening? If not, I would entertain a motion to adjourn.
