REPORTS OF CITY OFFICIALS

SAFETY DIRECTOR- Lou Carsone- Thank you Mr. President. As I said in caucus, I have a brief report of the tornado sirens. As everybody is aware, we had tornados in the area on the 16th of June and none of the sirens in the City of Hubbard, as well as some other areas, didn't work. Ed Palestro and I were on the phone during that trying to get the sirens to work. The next morning Mr. Palestro and I had a meeting. We also met with the Mayor and talked and tried to determine why our sirens didn't work. We contacted the 911 Center. We had communications with them and was made aware that when the tones went out during that siren, the tone that went out for our sirens, were sent out on the wrong frequency. I don't know why that happened. I am not sure they know why that happened, but they did correct that situation. On the 21st of June, after talking to the Mayor and Mr. Palestro, we did a test through the 911 Center after they fixed the situation there. We tested our sirens there twice. Mr. Palestro had people at all eight of the sirens in the city and the township and seven of them worked. The one at the fire station did not work on either of those tests. After the 911 Center tested theirs, we tested the old Zetron System that we use to use when we had dispatchers to see if that still worked at the police station. That system activated seven out of the eight sirens in the Hubbard City/Hubbard Township area. The one at the fire station still did not work. We made an attempt after that to activate that one alone and it didn't work. We have a problem with that siren. We know that and are working to get that fixed. The point is, at that test seven of the Hubbard City/Hubbard Township worked through the 911 Center and also through that Zetron System. In talking to the Mayor and Mr. Palestro, it is my intent here to come up with a formal written protocol of what we will do in the case of another tornado where the sirens don't activate. How we will activate them, who will be responsible for doing that and have several redundant back-up plans to that so that this doesn't happen again. I was advised by the Mayor that he had been contacted by Mr. Hanley who also wanted to have a discussion with us over this situation. We will do that in the near future also. I will keep council up to date on that plan as it goes along. That is all I have.

Mayor- inaudible

Mr. Carsone- I am sorry, those sirens can also be activated from portable units. Portable units are capable of doing that. We intend to buy several of those so we will have several portable radios that will be able to activate those sirens. That will become part of our written plan and written protocol.

Mr. Williams- So you are saying

Mr. Williams- Lou, so what you are saying is those portables will be in the hands of like an officer or Supervisor that is one duty or Police officer will have that capability then?

Mr. Carsone- Yes, if the police department becomes part of that plan, which I am sure they will at some point in time. We didn't want to tie an officer to the station to that Zetron there. This would give them the capability for the senior officer to take that out on the road if they would need that. I am not exactly sure where they would be placed but we will figure that out with the plan.

Mr. Williams- I think you guys have pretty much figured it out. It is just

Mr. Carsone- Yea, I think it is important to develop a written definite protocol. You can't account for every situation obviously but some redundancy in a backup plan is good.
