A RESOLUTION

**AUTHORIZING THE MAYOR OF THE CITY OF HUBBARD TO EXECUTE AND FILE AN APPLICATION WITH THE EASTGATE REGIONAL COUNCIL OF GOVERNMENTS FOR AN ODOT TRANSPORTATION ALTERNATIVES PROGRAM GRANT**

**WHEREAS**, the State of Ohio through the Ohio Department of Transportation provides financial assistance for projects that encourage transportation related activities that creatively integrate transportation improvement facilities into the surrounding communities and the natural environment; and,

**WHEREAS**, the City of Hubbard desires financial assistance from the Transportation Alternatives Program for the Myron Street Sidewalk Project.

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of Hubbard, Trumbull County, Ohio:

**SECTION 1:** That the Council of the City of Hubbard approves filing an application for financial assistance.

**SECTION 2:** That the Mayor of the City of Hubbard is hereby authorized and directed to execute and file an application with the Eastgate Regional Council of Governments, and to provide all information and documentation required to be eligible for possible funding assistance.

**SECTION 3:** That the City of Hubbard agrees to provide the funds required to satisfactorily complete the project and be eligible for reimbursement under the Transportation Alternatives Program.

**SECTION 4:** That the City of Hubbard agrees to maintain the project upon its completion.

**SECTION 5:** All prior Ordinances and Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

**SECTION 6:** All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
