AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH J. SEVERINO CONSTRUCTION FOR THE ERIE STREET SEWER REPLACEMENT PROGRAM, FOR A PRICE NOT TO EXCEED \$121,804.98, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio deems it necessary to improve and maintain the condition of Erie Street sewers; and

WHEREAS, the Erie Street Sewer Replacement Program was advertised and bid pursuant to Ohio law; and

WHEREAS, J. Severino Construction has submitted the lowest qualified bid for the project.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control of the City of Hubbard, Ohio, is hereby authorized and directed to enter into a contract with J. Severino Construction for the bid amount of \$121,804.98 for the Erie Street Sewer Replacement Program.

SECTION 2: The City Auditor is hereby authorized and directed to encumber the necessary funds from Sewer Replacement and Improvement, Fund No. 735-5030, Line Item No. 52340.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance due to extreme deterioration of the existing sewer line and shall take effect immediately upon passage and approval by the Mayor.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law
