ORDINANCE NO. 14-19

PASSED Dec 16 2019

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A ONE YEAR CONTRACT EXTENSION FOR BOTH TRASH AND RECYCLABLE PICKUP, BEGINNING FEBRUARY 1, 2020 AND ENDING JANUARY 31, 2021.

WHEREAS, the City of Hubbard, Ohio needs the services of collection and disposal of residential solid waste, recycling, and yard waste; and

WHEREAS, Browning-Ferris Industries of Ohio, Inc. DBA Republic Services of Youngstown was granted an exclusive franchise for the collection and disposal of residential solid waste, recycling, and yard waste in the City of Hubbard effective January 1, 2015 through December 31, 2017; and

WHEREAS, the City of Hubbard has already entered into one contract extension.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized to enter into a one year contract extension for both trash and recyclable pickup with Republic Services of Youngstown beginning February 1, 2020 and ending January 31, 2021 with a \$1.50 per month increase in February, 2020 with all discount values remaining the same, including but not limited to senior discount.

SECTION 2: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
