AN ORDINANCE

AMENDING THE MEMORANDUM OF UNDERSTANDING CREATED BY ORDINANCE 19-18, ESTABLISHING A SCHOOL RESOURCE OFFICER, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio wants to prevent and reduce potential harm related to incidents of school violence and foster a positive school climate; and

WHEREAS, due to the corona virus pandemic commencing on or about March, 2020 resulting in school closures; and

WHEREAS, the Hubbard Exempted School District and the City of Hubbard desire to adjust the compensation of the School Resource Officer as a result of the pandemic for year two only of the agreement; and

WHEREAS, the Hubbard Exempted School District and the City of Hubbard have agreed upon a revised year two compensation amount for the School Resource Officer that is equitable for both parties.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the year two compensation for the School Resource Officer shall be amended as follows:

a. Total amount due to the City of Hubbard for year two only will be \$43,757.16 payable to the City of Hubbard by the Hubbard Exempted School District. Compensation adjustment is due to the corona virus pandemic and forced closure of school.

b. Included in only year two of compensation, starting August 3, 2020 until August 21, 2020, the School Resource Officer will be available for use by the Hubbard Exempted School District.

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
