A RESOLUTION

AUTHORIZING THE AUDITOR TO CREATE A SPECIAL REVENUE FUND, NUMBER 202, ENTITLED *CARES ACT FUND*.

WHEREAS, the City of Hubbard, Ohio, wishes to comply with Auditor of State Bulletin 2000-008, which dictates the prescribed accounting treatment of intergovernmental monies, received for the administration of Federal monies for pandemic assistance.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: There is hereby created a Special Revenue Fund, Number 202, entitled *CARES ACT FUND*.

SECTION 2: The Special Revenue Fund, Number 202, shall have one (1) budgetary revenue line item and two (2) budgetary expense line items, as follows:

- Line Item 202-0000-4-1490, entitled *Other Governmental Assistance (Revenue)*.
- Line Item 202-2010-5-2520, entitled *Capital Projects (Expense)*.
- Line Item 202-7092-5-2352, entitled *Refund to US Treasury (Expense)*.

SECTION 3: All prior Ordinances and Resolutions or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
