AN ORDINANCE

AMENDING VARIOUS LINE ITEM APPROPRIATIONS IN THE 2020 BUDGET AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard must amend its budget to accommodate the expenses relating to various costs and other necessary changes in the budget; and

WHEREAS, line item appropriation amendments are necessary in order to expend the required funds.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The City Auditor of Hubbard, Ohio, is hereby authorized and directed to amend the line item appropriations in the 2020 budget as follows: Street Fund- Capital Projects line item: Original Appropriation \$100,000.00. Revised Appropriation \$150,000.00.

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the fact that the funds required by this change are immediately necessary, and time is of the essence, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
