AN ORDINANCE

ALLOCATING AND ENCUMBERING FUNDS FROM THE CORONAVIRUS RELIEF FUND DISTRIBUTED TO THE CITY OF HUBBARD, OHIO AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard has received funds from the Coronavirus Relief Fund as established by the CARES Act to combat the COVID 19 virus; and

WHEREAS, the City of Hubbard has and will incur additional expense in the mitigation, prevention, and continuing efforts to protect citizens and employees from the COVID 19 virus.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Council of the City of Hubbard, Ohio, has agreed that the following expenditures attached herewith and labeled as EXHIBIT A, and incorporated by reference are hereby necessary to mitigate, and prevent the spread of the COVID 19 virus.

SECTION 2: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio, it's citizens, employees and the general public by virtue of the fact that the COVID 19 virus must be prevented from spreading. The attached EXHIBIT A expenditures are immediately necessary, and time is of the essence, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
