ORDINANCE NO. 4-21

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO EXECUTE A THREE-YEAR CONTRACT FOR THE 2021 - 2023 CALENDAR YEARS WITH CIRCLE K, HUBBARD, OHIO FOR THE PURCHASE OF FUEL FOR CITY VEHICLES AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio has publicly advertised for bids for gasoline; and
WHEREAS, Circle K, Hubbard, submitted a bid for gasoline for city vehicles and has been determined to be the lowest and best bidder, it is desired to award and execute said contract as presented through the public bid process.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the Board of Control is authorized and directed to execute a contract with Circle K, Hubbard, for the purchase of fuel for City vehicles commencing January 1, 2021.

SECTION 2: The City Auditor is hereby authorized and directed to encumber the amount necessary for this contract as invoiced for monthly gasoline purchases in the appropriate funds and line items.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance for the health, safety, and welfare of the City of Hubbard and as such shall take effect upon its passage and approval by the Mayor, or in the alternative, from the earliest time permitted by law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
