A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO APPROVE THE EXTENSION OF THE RENEWABLE CONTRACT BETWEEN TRUMBULL COUNTY, OHIO, AND THE CITY OF HUBBARD, OHIO, PROVIDING FOR THE REPRESENTATION OF INDIGENT MISDEMEANANTS IN THE GIRARD MUNICIPAL COURT COMMENCING JANUARY 1, 2021 AND TERMINATING DECEMBER 31, 2021.

WHEREAS, the City of Hubbard, Ohio, recognizes its responsibility under the laws of the State of Ohio and the United States of America to provide legal counsel to indigent persons charged with a violation of a city ordinance for which penalty or any possible adjudication provides for the loss of liberty; and

WHEREAS, Trumbull County, Ohio, has adopted a program whereby the County Commissioners have contracted with the State of Ohio to provide indigent defense services in the County of Trumbull; and

WHEREAS, the County Commissioners pursuant to Ohio Revised Code Sections 120.14 and 120.16 may enter into a contract with a municipal corporation whereby the county provides legal representation to indigent adults and juveniles charged with a violation of an ordinance of a municipal corporation for which penalty or any possible adjudication provides for the loss of liberty; and

WHEREAS, the City of Hubbard, Ohio, has previously entered into such a contract that is renewable on a yearly basis.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to approve the extension of the renewable contract with Trumbull County, Ohio, for the representation of indigent adults and juveniles charged with a violation of an ordinance of the City of Hubbard, Ohio, for which any penalty or adjudication provides for the loss of liberty and appropriated funding in the amount of \$500.00 annually for same. ( A copy of said Agreement/Renewal is attached hereto as Exhibit A and incorporated herein as if fully re-written.)

SECTION 2: All prior Ordinances and Resolutions or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.


