AN ORDINANCE

**ADJUSTING THE COMPENSATION OF THE MAYOR'S SECRETARY TO: EFFECTIVE JANUARY 1, 2021, \$35,400, EFFECTIVE JANUARY 1, 2022, \$35,900, AND EFFECTIVE JANUARY 1, 2023, \$36,500.**

WHEREAS, the City Council of the City of Hubbard, Ohio wishes to compensate the Mayor's Secretary at a rate of pay commensurate with the duties and responsibilities of the position and office.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The salary of the Mayor's Secretary shall be increased from Thirty Five Thousand Dollars (\$35,000) to a salary of Thirty Five Thousand Four Hundred Dollars (\$35,400.00) and shall be effective January 1, 2021. And the salary of the Mayor's Secretary shall then be increased from Thirty Five Thousand Four Hundred Dollars (\$35,400.00) to Thirty Five Thousand Nine Hundred Dollars (\$35,900.00) effective January 1, 2022. And the salary of the Mayor's Secretary shall then be increased from Thirty Five Thousand Nine Hundred Dollars (\$35,900.00) to Thirty Six Thousand Five Hundred Dollars (\$36,500.00) effective January 1, 2023.

SECTION 2: The Mayor's Secretary, shall be entitled to and granted participation in the Ohio Public Employees Retirement System, life insurance, hospitalization, medical benefits, and prescription drug coverage, and other benefits granted to the Hubbard City employees by way of collective bargaining agreements, and such other benefits as from time to time may be awarded unless otherwise excluded by valid resolution or ordinance of this Council.

SECTION 3: The City Auditor is hereby authorized and directed to appropriate the necessary funds from the proper City line items and funds in accordance with the relevant percentages to effectuate the foregoing provisions.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
