A RESOLUTION

ADOPTING THE UPDATED TRUMBULL COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN

WHEREAS, natural, technological and man-made hazards can affect the City of Hubbard; and

WHEREAS, significant structural, historical, and economic losses could result from an occurrence of a natural, technological, or man-made hazard event; and

WHEREAS, undertaking mitigation projects during pre-disaster periods could decrease the total losses the City of Hubbard may incur as the result of said hazard occurrence; and

WHEREAS, the City of Hubbard has a strong interest in reducing or mitigating potential losses from future hazard occurrences; and

WHEREAS, the hazard mitigation plan is a federal and state mandate to maintain eligibility for hazard mitigation funding, and by that federal and state mandate said plan must be updated a minimum of every five years; and

WHEREAS, a cooperative and joint effort is a proven efficient manner to plan for and reduce hazard susceptibility in all government jurisdictions in Trumbull County, Ohio.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The City of Hubbard has partnered with Trumbull County to update the existing "Trumbull County Multi-Jurisdictional Hazard Plan" to further identify, define, and characterize the hazards affecting the City of Hubbard as well as continuing to identify and prioritize projects that could lessen hazard vulnerability.

SECTION 2: The City of Hubbard hereby adopts the updated "Trumbull County Multi-Jurisdictional Hazard Mitigation Plan" upon passage of this Resolution.

SECTION 3: All prior Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
