Dear Water Customer: The city of Hubbard is required by Ohio Administrative Code (OAC) to conduct periodic surveys and investigations of potential cross-connections to the public water supply. Therefore, for the safety of all the potable water consumers that the city of Hubbard services, we are requesting that customers perform a quick survey of their premises for potential cross-connection hazards. To assist all in this process the city of Hubbard has created a cross-connection questionnaire.

#### Ohio Administrative Code

#### 3745-95 Backflow Prevention and Cross-Connection Control

#### 3745-95-03 Surveys and investigations.

(A) The supplier of water shall conduct or cause to be conducted an initial assessment and periodic surveys or investigations of water use practices within a consumer's premises to determine whether there are actual or potential cross-connections to the consumer's water system through which contaminants or pollutants could backflow into the public water system.

(B) The supplier of water, or the supplier's authorized representative, shall have the right to enter premises served by the public water system at all reasonable times for the purpose of making surveys and investigations of water use practices within the premises.

(C) On request by the supplier of water, or the supplier's authorized representative, the consumer shall furnish the supplier, or the supplier's authorized representative, information on water use practices within the consumer's premises.

(D) Paragraph (A) of this rule does not relieve the consumer of the responsibility for conducting, or causing to be conducted, periodic surveys of water use practices on his premises to determine whether there are actual or potential cross-connections 3745-95-03 2 in the consumer's water system through which contaminants or pollutants could backflow into a public water system or a potable consumer's water system.
