A RESOLUTION ACCEPTING FEDERAL AMERICAN RESCUE PLAN ACT OF 2021 MONIES.

WHEREAS, the City of Hubbard is eligible for funding from the Coronavirus State and Local Fiscal Recovery Funds of H.R. 1319 American Rescue Plan Act of 2021 (CSLRF).

WHEREAS, the State of Ohio General Assembly will provide for the distribution of funds to eligible Ohio municipalities; and

WHEREAS, before receiving a payment, the City Council is required to formally accept the CSLRF funds;

WHEREAS, revenue received under the CSLRF must only be spent for purposes authorized by the CSLRF, and applicable regulations, and by state law;

WHEREAS, revenue received under the CSLRF must be accounted for in a separate fund and not co-mingled with other revenue for accounting purposes; and

WHEREAS, the City of Hubbard must comply with all applicable budgeting, accounting, contracting, reporting, and other compliance requirements for CSLRF funds.

NOW, THEREFORE, BE IT RESOLVED by the City Council of the City of Hubbard that we do hereby accept and request CSLRF funding to be distributed by the State of Ohio; and

Section 1: The City of Hubbard affirms that the CSLRF revenue will only be used for the purposes prescribed in the CSLRF, and in US Treasury guidance in 31 CFR, Part 35, and any applicable regulations, and in accordance with state law; and

Section 2: The City of Hubbard will comply with procedures created by the State of Ohio General Assembly and the US Treasury Department to receive funds under the act; and

Section 3: The City of Hubbard will account for CSLRF in a separate fund and not co-mingle it with other revenues for accounting purposes and will comply with all applicable federal and state budgeting, accounting, contracting, reporting, and other compliance requirements for CSLRF funds; and

Section 4: The City Council of the City of Hubbard designates and directs the Mayor and City Auditor to take all actions necessary on behalf of the town council to receive the CSLRF funds.

Section 5: All prior Resolutions or parts thereof in conflict with this Resolution are hereby repealed.

Section 6: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any committees leading to such action, were in meetings open to the public as required by law.
