AN ORDINANCE

AUTHORIZING THE MAYOR TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER SUPPLY REVOLVING LOAN ACCOUNT (WSRLA) DESIGN AND/OR CONSTRUCTION LOAN AGREEMENT ON BEHALF OF THE CITY OF HUBBARD FOR THE 2023 WATERLINE REPLACEMENT PROJECT.

WHEREAS, the City of Hubbard seeks to replace approximately 5,000 lineal feet of existing 6" diameter water line on Caroline and Rebecca Avenues; and

WHEREAS, the City of Hubbard intends to use American Rescue Plan Act (ARPA) funding towards the completion of this project; and

WHEREAS, the City of Hubbard intends to apply for WSLRA low-interest loan funding through the Ohio EPA for the engineering design and/or construction of the 2023 Waterline Replacement Project to cover the balance of project costs; and

WHEREAS, the Ohio EPA WSLRA requires the government authority to pass legislation for application of a loan and the execution of an agreement as well as designating a dedicated repayment source in the event principal forgiveness is not obtained.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Ohio:

SECTION 1: The Mayor is hereby authorized to apply for and enter a WSLRA design and/or construction loan agreement with the Ohio EPA and the Ohio Water Development Authority for the replacement of water lines on Caroline and Rebecca Avenues on behalf of the City of Hubbard, Ohio.

SECTION 2: The dedicated source of repayment will be the water user fees.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
