A RESOLUTION

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO AN AGREEMENT WITH THE GEAGA-TRUMBULL SOLID WASTE MANAGEMENT DISTRICT FOR THE RIGHT OF ENTRY AND USE OF PROPERTY FOR DROP-OFF RECYCLING CONTAINERS. THE RENEWAL TERM IS JANUARY 1, 2023, THROUGH DECEMBER 31, 2023.

WHEREAS, funds for the program have been authorized by the Geauga-Trumbull Waste Management District from January 1, 2023 through December 31, 2024; and

WHEREAS, the City of Hubbard desires to facilitate the recycling program by securing use of City property in order to place one or more recycling containers for the use and convenience of City residents; and

WHEREAS, the Geauga-Trumbull Waste Management District will contract with an approved waste hauler for the removal of recyclables from the containers; and

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County,

Ohio:

SECTION 1: The Board of Control is hereby authorized to enter into an agreement with Geauga-Trumbull Solid Waste Management District for the right of entry and use of property for drop-off recycling containers for the initial term of January 1, 2023, through December 31, 2023. A copy of the agreement is attached as exhibit A consisting of 3 pages and is incorporated herein as if fully rewritten.

SECTION 2: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
