AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH J.S. BOVA EXCAVATING, LLC. CONTINGENT UPON RECEIVING OHIO EPA WATER SUPPLY REVOLVING LOAN ACCOUNT FUNDING FOR THE 2022 LEAD SERVICE LINE REPLACEMENT PROJECT AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio deems it necessary to replace lead service lines; and

WHEREAS, the 2022 Lead Service Line Replacement Project was advertised and bid pursuant to law; and

WHEREAS, the City of Hubbard is in the process of obtaining a loan through the Ohio EPA Water Supply Revolving Loan Account (WSRLA) to fund the improvements in conjunction with an H2Ohio Grant.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That the Board of Control of the City of Hubbard is hereby authorized and directed to enter into an agreement and contract with J.S. Bova Excavating, LLC, accepting the base bid in the amount of \$228,214.00 for the completion of the 2022 Lead Service Line Replacement Project in accordance with the specifications as prepared by ms consultants and the City Engineer's Office.

SECTION 2: Acceptance of the bid and execution of the agreement and contract with J.S. Bova Excavating, LLC is contingent upon receiving satisfactory funding through the Ohio EPA Water Supply Revolving Loan Account.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the fact that lead service lines need to be replaced in the most timely of fashions in order to maintain a safe water distribution system, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.


