AN ORDINANCE

**AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH C.R. ELECTRIC, INC. FOR THE CREED AVENUE BOOSTER STATION GENERATOR PROJECT AND DECLARING AN EMERGENCY.**

WHEREAS, the City of Hubbard, Ohio, deems it necessary to provide standby power for the Creed Avenue Booster Station, and

WHEREAS, the Creed Avenue Booster Station Generator Project was advertised and bid pursuant to law, and

WHEREAS, the City of Hubbard has obtained a grant through the Ohio EPA of \$50,000.00 to help fund the generator project, and

WHEREAS, local funding will be used to cover the balance of the project cost.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: That the Board of Control of the City of Hubbard, Ohio, is hereby authorized to enter into an agreement and contract with C.R. Electric, Inc. for an amount not to exceed \$69,895.00 for the completion of the Creed Avenue Booster Station Project as described in the bid specifications prepared by ms consultants, inc., and the City Engineer's Office.

SECTION 2: This Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the mayor, or from the earliest time permitted by law, for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard, Ohio.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
