**AN ORDINANCE**

ADJUSTING THE COMPENSATION OF THE BACKFLOW AND CROSS CONNECTION COORDINATOR TO \$1,000.00 PER MONTH WITH PARTICIPATION IN OHIO PUBLIC EMPLOYEE RETIREMENT SERVICES AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio operates and maintains a municipal water system; and

WHEREAS, the City of Hubbard municipal water system must be in compliance with EPA rules and regulations; and

WHEREAS, the installation, inspection and maintenance of backflow preventers and cross connection oversight is a requirement of the EPA rules; and

WHEREAS, the City Council of the City of Hubbard, Ohio has established the position of Backflow and Cross Connection Coordinator to meet the EPA requirements, maintain water quality, and help with the backflow program.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The position of Backflow and Cross Connection Coordinator shall be compensated at a rate of \$1,000.00 per month with participation in Ohio Public Employee Retirement Services.

SECTION 2: The City Auditor is hereby authorized and directed to appropriate the necessary funds from "Other Wages", Fund No. 715-5020-52116.

SECTION 3: This Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard Ohio, to maintain water quality for all citizens, and to comply with EPA requirements in a timely manner.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
