AN ORDINANCE

ADOPTING FINAL LINE-ITEM APPROPRIATION AMENDMENTS IN THE 2023 BUDGET AND
DECLARING AN EMERGENCY.

WHEREAS, it is necessary to amend various departmental appropriations in the 2023
budget; and

WHEREAS, the Auditor of the City of Hubbard, Ohio, has prepared a listing of the
necessary revisions in order to facilitate the closing of financial records and preparation
of financial statements.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County,
Ohio:

SECTION 1: The Auditor of the City of Hubbard, Ohio, is authorized by the City Council of
Hubbard, Ohio, to amend the departmental appropriations in the 2023 budget as set forth on
attached Exhibit "A" which is incorporated as if fully rewritten herein and is made a part of this
Ordinance hereof by reference.

SECTION 2: The Auditor is hereby directed and authorized to perform any and all
necessary year-end interfund transfers and advances as detailed in the accompanying Exhibit "A"
in order to facilitate year-end budget balance.

SECTION 3: The Clerk of Council is hereby instructed to file a certified copy of this
Ordinance, with all attached Exhibits, with the proper signatures affixed hereto and contained
and executed thereon, with the Auditor of Trumbull County, Ohio, acting in his capacity as
Secretary of the Trumbull County Budget Commission.

SECTION 4: This Ordinance is hereby declared to be an emergency due to time restraints
regarding compliance with state law.

SECTION 5: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby
repealed.

SECTION 6: All formal actions of the City Council of Hubbard, Ohio relating to the adoption
of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its
committees leading to such action, were in meetings open to the public as required by law.
