AN ORDINANCE

ADOPTING AN OPERATING BUDGET FOR THE CITY OF HUBBARD, OHIO, AND ESTABLISHING ANNUAL APPROPRIATIONS IN VARIOUS CITY FUNDS FOR THE 2024 FISCAL YEAR AND DECLARING AN EMERGENCY.

WHEREAS, the City Council of the City of Hubbard, Ohio wishes to establish an operating budget of appropriations for all city funds and departments for the 2024 calendar year.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The amounts to be appropriated for the routine operation of all city departments and funds for the City of Hubbard, Ohio for the 2024 fiscal year are hereby adopted as set forth and contained in Exhibit "A" consisting of _____ pages, and entitled *Budget Appropriation Ordinance for the Year 2024* as presented by the Hubbard City Auditor, which is incorporated as if fully rewritten herein and is made a part of this Ordinance hereof by reference.

SECTION 2: The Clerk of Council is hereby instructed to file a certified copy of this Ordinance, with all attached Exhibits, with the proper signatures affixed hereto and contained and executed thereon, with the Auditor of Trumbull County, Ohio, acting in his capacity as Secretary of the Trumbull County Budget Commission.

SECTION 3: This Ordinance is hereby declared to be an emergency due to time restraints regarding compliance with state law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
