ORDINANCE NO. 2-24

PASSED JANUARY 2 2023

AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT ON BEHALF OF THE CITY OF HUBBARD, OHIO, WITH THE AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES (AFSCME), OHIO COUNCIL 8, Local 1256 AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio administration has conducted negotiations with the American Federation of State, County, and Municipal Employees (AFSCME), Ohio Council 8, Local 1256; and

WHEREAS, such negotiations have provided a tentative agreement between the parties; and

WHEREAS, City Council and the administration have reviewed such proposal and do desire to ratify, adopt, and execute such agreement.

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Trumbull County, State of Ohio:

SECTION 1: The Board of Control is hereby authorized and directed to enter into an agreement with the American Federation of State, County, and Municipal Employees (AFSCME), Ohio Council 8, Local 1256 on behalf of the City of Hubbard, Ohio, a copy of which agreement/contract is attached hereto and made part hereof as though fully rewritten here by reference, marked as "Exhibit A".

SECTION 2: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the fact that current union employee contracts expired December 31, 2023, and therefore time is of the essence, and as such, this Ordinance shall take effect immediately upon its passage and approval by the Mayor, or in the alternative, from and after the earliest time permitted by law.


