**AN ORDINANCE**

AUTHORIZING THE 2024 MONTHLY HOSPITALIZATION RATES FOR ELECTED OFFICIALS, POLICE EMPLOYEES AND AFSCME UNION EMPLOYEES, AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio provides hospitalization benefits for its elected officials, police employees and AFSCME union employees; and

WHEREAS, the City of Hubbard must adjust the monthly hospitalization rates from time to time;

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The 2024 monthly hospitalization rates shall be;

**ELECTED OFFICIALS AND POLICE EMPLOYEES**

Single	\$ 1,174.87
Married/Family	\$ 2,700.26

**AFSCME UNION EMPLOYEES**

Single	\$1,159.19
Married/Family	\$ 2685.82

SECTION 2: The City Auditor is hereby authorized and directed to appropriate the necessary funds from the various departmental line item accounts.

SECTION 3: This Ordinance is hereby declared to be an emergency measure and shall take effect immediately upon passage and approval by the Mayor for the reason that it is necessary for the health, safety, and welfare of the citizens of the City of Hubbard Ohio, to maintain compliance with State Auditor requirements.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
