AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH MS CONSULTANTS, INC. FOR THE ENGINEERING SERVICES ASSOCIATED WITH THE TRU-ELMWOOD DRIVE PROJECT (ODOT PID NO. 117398) AND DECLARING AN EMERGENCY.

WHEREAS, Resolution No. 3-22, passed by the Council of the City of Hubbard on April 18, 2022 authorizing the Board of Control to apply for the Federal Surface Transportation Block Grant (STBG) funds programmed by the Eastgate Regional Council of Governments; and

WHEREAS, the City of Hubbard, Ohio, was awarded funding through the STBG program for the TRU-Elmwood Drive Project (ODOT PID No. 117398); and,

WHEREAS, the City of Hubbard has selected ms consultants, inc. to provide the engineering services for this project in accordance with the Qualification Based Selection Law described in Ohio Revised Code Section 153.65-153.73; and,

WHEREAS, the project is considered an ODOT Let project and the City of Hubbard has worked in conjunction with ODOT and ms consultants, inc. to develop the appropriate engineering services in accordance with the ODOT requirements.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control of the City of Hubbard, Ohio is authorized to enter into an agreement and contract with ms consultants, inc. in the amount of \$72,661.00 for preliminary and final engineering services in accordance with the project requirements as prepared by ms consultants, inc. and reviewed and approved by the City of Hubbard and ODOT.

SECTION 2: All prior Resolutions and Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 3: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
