AN ORDINANCE

AUTHORIZING THE BOARD OF CONTROL TO ENTER INTO A CONTRACT WITH QUASAR ENERGY GROUP FOR SLUDGE HAULING AND DISPOSAL FOR THE WASTEWATER TREATMENT FACILITY FROM JANUARY 1, 2024 TO DECEMBER 31, 2025, AT A COST OF \$112.66 PER WET TON AND DECLARING AN EMERGENCY.

WHEREAS, the City of Hubbard, Ohio needs the services of pickup, hauling, and disposal of dewatered sludge; and

WHEREAS, Quasar Energy Group submitted the lowest and best bid for said services for the above referenced time period.

NOW, THEREFORE, BE IT ORDAINED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: The Board of Control of the City of Hubbard, Ohio, is hereby authorized and directed to execute and award a contract with Quasar Energy Group for the pickup, hauling, and disposal of dewatered sludge at a cost of \$112.66 per wet ton. The bidding process was conducted pursuant to the provisions of Ohio law.

SECTION 2: The City Auditor is hereby authorized and directed to encumber the amount necessary for this contract in the Sewer Fund #730-5030-52150, Sludge Removal.

SECTION 3: This Ordinance is hereby declared to be an emergency Ordinance necessary for the health, safety, and welfare of the City of Hubbard, Ohio by virtue of the facts mentioned in the preamble hereto, which is made part hereof, as that sludge hauling and disposal are necessary requirements as dictated by the EPA for compliant operation of the Waste Water Treatment Facility, and as such, this Ordinance shall take effect immediately upon passage and approval by the Mayor, or in the alternative, from the earliest time permitted by law.

SECTION 4: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 5: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
