~~AUTHORIZING THE SERVICE DIRECTOR TO APPLY FOR, ACCEPT, AND ENTER INTO A WATER POLLUTION CONTROL-LOAN-FUND-(WPCLF)-CONSTRUCTION-LOAN-AGREEMENT-ON-BEHALF-OF THE CITY OF HUBBARD FOR THE SANITARY SEWER IMPROVEMENT PROJECT, AND DECLARING AN EMERGENCY.~~

~~WHEREAS, the City of Hubbard, Ohio desires to perform infrastructure upgrades to the Hall Avenue sanitary sewer and miscellaneous improvements to the pump stations at Timber-Point, North Main-Street, and the Wastewater Treatment Plant; and~~

~~WHEREAS, the City of Hubbard, Ohio intends to use Ohio Department of Development Water and Wastewater Infrastructure Grant and local funding towards the completion of the project; and~~

~~WHEREAS, the City of Hubbard intends to apply for WPCLF low-interest loan funding through the Ohio EPA for the replacement of generators at the Timber Point and North Main Street pump stations; and~~

~~WHEREAS, the Ohio EPA WPCLF requires the government authority to pass legislation for application of a loan and the execution of an agreement as well as designating a dedicated repayment source in the event principal forgiveness is not obtained.~~

NOW, THEREFORE, BE IT ORDAINED by the Council of the City of Hubbard, Ohio:

SECTION 1: The Service Director is hereby authorized to apply for and enter a WPCLF construction loan agreement with the Ohio EPA and the Ohio Water Development Authority for the Sanitary Sewer Improvement Project on behalf of the City of Hubbard, Ohio. Project consists of infrastructure upgrades to the Hall Avenue sanitary sewer and miscellaneous improvements to the pump stations at Timber Point, North Main Street, and the Wastewater Treatment Plant.

SECTION 2: The dedicated source of repayment will be the sanitary user fees.

SECTION 3: This Ordinance is hereby declared an emergency due to the limited time frame for applicants to receive the available funding through the Water Pollution Control Loan Fund.

SECTION 3: All prior Ordinances or parts thereof in conflict with this Ordinance are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Ordinance, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meeting open to the public as required by law.
