WHEREAS various bridges throughout Trumbull County and the City of Hubbard have
been renamed to honor the military men and women who selflessly served our country;
and,

WHEREAS the City of Hubbard wishes to extend the same recognition to all past and
present first responders of the City of Hubbard; and,

WHEREAS the Council of the City of Hubbard wishes to formally support the renaming of
bridge number TRU 62 0398 on U.S. Route 62 (North Main Street) to honor first
responders that have and are serving the City of Hubbard.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County,
Ohio:

SECTION 1: That Hubbard City Council and Administration hereby support renaming
bridge number TRU 62 0398 on U.S. Route 62 (North Main Street) as the "Hubbard First
Responders Bridge".

SECTION 2: The Clerk of Council is hereby directed to forward certified copies of this
Resolution to State Senator Sandra O'Brien.

SECTION 3: All prior Resolutions and Ordinances or parts thereof in conflict with this
Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption

law.


