A RESOLUTION BY THE COUNCIL OF THE CITY OF HUBBARD, OHIO IN SUPPORT OF RENAMING EAST PARK AVENUE BRIDGE (HUBC 05) ON EAST PARK AVENUE, TO BE RENAMED "WORLD WAR I AND WORLD WAR II VETERANS MEMORIAL BRIDGE"

WHEREAS, various bridges throughout Trumbull County have been renamed to honor the military men and women who selflessly served our country; and,

WHEREAS, the Council of the City of Hubbard wishes to formally support the renaming of the East Park Avenue bridge located on East Park Avenue honor veterans who have served in World War I and World War II.

NOW, THEREFORE, BE IT RESOLVED by the City Council of Hubbard, Trumbull County, Ohio:

SECTION 1: That Hubbard City Council and Administration hereby support renaming East Park Avenue bridge (HUBC 05C) as the "World War I and World War II Veterans Memorial Bridge"

SECTION 2: The Clerk of Council is hereby directed to forward certified copies of this Resolution to the Trumbull County Commissioners and the Trumbull County Engineer.

SECTION 3: All prior Resolutions and Ordinances or parts thereof in conflict with this Resolution are hereby repealed.

SECTION 4: All formal actions of the City Council of Hubbard, Ohio relating to the adoption of this Resolution, and all deliberations of the City Council of Hubbard, Ohio and any of its committees leading to such action, were in meetings open to the public as required by law.
